RULES & REGULATIONS (Before filling application forms read rules carefully):

1. Students are advised to carefully read all the instructions before submitting the form.
2. A candidate must be citizen of India. Must have passed SSC & HSC from Maharashtra state.
3. Domiciled Candidates of Maharashtra are **only** eligible. The candidate shall submit Domicile Certificate along with application form (Residential proof will not be considered as Domicile).
4. A candidate Domiciled in Maharashtra but having constitutional reserved category documents of other state will not be eligible for reserved category claim. However, if such candidate submits Domicile certificate, he/she shall be considered for admission as open category student.
5. Candidate who has passed HSC examination with Physics, Chemistry & Biology (PCB) shall be eligible.
6. Candidate who have passed HSC examination (Medical Lab Technician-1, 2 & 3) are also eligible for concerned specialty technical course ONLY.
7. Eligible Candidate must have born on or before **31-12-2004**.
8. **The student should apply in person** (anybody on behalf of student can submit application). Kindly note, the application format is attached to this advertisement. The same format without any editing/additions should be used for submission. Student should download the advertisement print application form back-to-back. The students shall submit applications to CET CELL, Govt. Medical college, Aurangabad college campus building, ground floor.
9. Application along with all self-attested documents will be mandatory. The student should verify all information in the application before final submission. Corrections / Over writing / scratching in the application form will NOT be accepted. **Application will NOT be accepted via email/Fax/Post/Courier. Application Forms will be accepted after verification by scrutiny committee during.**
10. **All documents enlisted in the advertisement will be compulsorily required. Irrespective of reasons, any candidate unable to submit all necessary documents, his/her form will be rejected. Receipts/ acknowledgements /undertaking on bond will NOT be considered as an alternative to any documents. It is important to note that NO certificate(s) will be attached to application after the last date of submission for any claims.**

11. Merit & Selection list will be displayed on the Govt. Medical College, Aurangabad college website (www.gmcaurangabad.com) & College CET CELL Notice Board as per the schedule. The source of all information pertaining to advertisement, amendments to advertisement, selection and joining will be made available on the college website: www.gmcaurangabad.com. Students should regularly check website for updates/changes/amendments.
12. Selection of the candidates shall be based on the merit of total marks obtained in HSC-PCB (physics Chemistry & Biology Total)/ equivalent marks as per clause No.4 mentioned above.
13. For preparing merit list, total marks of PCB after considering attempts shall be considered (for calculating the final total marks of PCB marks, subject wise attempt shall be made applicable; for each subject if the candidate has attempt, 2 marks will be deducted per attempt per subject). If tie of PCB total persists then, grand total of HSC after considering deduction of 2 marks for each attempt, followed by grand total marks of SSC, followed by age will be the criteria for preparing merit list.
14. Category students should produce Caste certificate, Caste validity & Non-Creamy layer certificate valid up to **31-3-2022**. It is important to note that all category documents will be required for category claim, Receipts / acknowledgements of proposals submitted / undertaking on bond for consideration of category claims will **NOT** be accepted as alternative to category claim documents. If students are not producing these documents on or before the last date of submission, they will be considered as Open category students. Kindly note no certificate(s) will be attached to application after the last date of submission for category claim. The category of student will be final after last date of submission.
15. Candidates claiming EWS should submit the EWS certificate (**Annexure-A**) in the prescribed format issued by Govt. of Maharashtra.
16. Inter-se amongst the reserved categories will be operated at the end of each admission process against the unfilled reserved categories seats as per merit and choice of the reserved categories candidates. The seats remaining vacant from various categories will be filled in during inter-se admission process as follows:
 - a) From among the candidates of their respective group from the Inter-se Merit List of that particular group where the vacancies exist.
 - b) If the seats still remain vacant, then the seats will be filled, from among the candidates of all the categories mentioned above from all categories combined merit list.
 - c) If the seats remaining vacant then the seats will be filled from among the candidates of the common merit list
 - d) The seats remaining vacant from EWS category will be allotted to general category candidate.

17. Candidates will be required to submit all original certificates at the time of joining. **Admission will not have finalized without submission of all required original documents.**
18. **Students can fill minimum one to maximum 11 Choices. While filling the choices Scratching & over writing will not be considered. It is highly advisable to all students to fill 11 choices. Don't just fill seats for your category but fill all choices. As per the preferences seat will be allotted. The seat matrix is likely to be changed and final allotment will depend on the changes. So, students are advised to fill all choices in the preference form.**
19. **FEES:** Demand draft of total fees from nationalized bank as prescribed in the advertisement will be required after the allotment of seat. **Cash/Cheque will not be accepted.**

20. **STATUS RETENTION:** It means the student can freeze the allotted choice after allotment. Giving status retention is not compulsory. The students can give Status Retention in the prescribed format on or before **19-10-2020** till 5:00 PM. Once status retention is given the seat allotment of the candidate becomes full and final. All allotted seats will automatically become full and final after cut-off date.
21. **The cutoff date of admission is 31-10-2021. No upgradation in choices will be done even if seats remain vacant. If for any reasons, admission cancellation request is submitted by the student, then FEES WILL NOT BE REFUNDED.**
22. **CONDUCT AND DISCIPLINE:** Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. 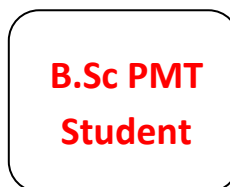
24. In case the seats remain Vacant after cutoff date and Govt./University issues notification for extension rounds, then following rules will be followed:
