**Eligibility:-**

- Eligible candidates must have passed ***B.Sc degree from Dr Babasaheb Ambedkar Marathwada University, Aurangabad (BAMU)*** statutory /recognized University,

with B.Sc. in Botany /Zoology / Chemistry /Microbiology or B.Sc. in life science or B.Sc. in MLT (Medical laboratory technician)

- Should have passed with at least 50% aggregate marks of B.Sc. For the open category and 40% aggregate marks of B.Sc. for the reserved category.
  - Other University candidates of Maharashtra and outside Maharashtra are also eligible to apply.

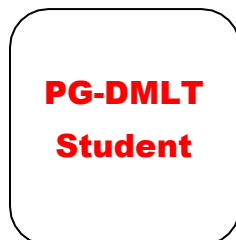
## Rules and Regulations:

1. Admissions will be made as per the rules and directives laid down by DMER and Instructions from MUHS Nashik.
2. No hostel facilities are available for this course.
3. Admission is subject to approval, Registration & Eligibility by the Maharashtra University of Health Sciences, Nashik. The Maharashtra University of Health Sciences Nashik will finalize the Eligibility of the students. Candidates who have been selected for PG-DMLT Course are required to submit registration & Eligibility forms of MUHS Nashik within 10 days after admission with necessary fees as per the rules.
4. Merit list will be prepared as per the total aggregate marks' percentage of B.Sc. inclusive of all years and semesters after calculating attempts.

**Deductions from total aggregate marks for the final total will be calculated as follows.**

- Passing the subjects at 1<sup>st</sup> attempt – No deductions
  - Passing the subjects at 2<sup>nd</sup> attempt – 3 marks
  - Passing the subjects at 3<sup>rd</sup> attempt – 5 marks
5. After the cutoff date for admission, if the candidate cancels the admission, then the fees deposited will not be refunded.
  6. All selected students should use a white apron and the pocket of the apron shall have compulsory print or embroidery as below: The dress code if Decided by the institute shall be mandatory for all PG-DMLT students. Strict action will be initiated against students not following the instructions.

### Selection process:-

1. The candidate will have to **appear for an interview** at their own cost as per the schedule.
2. If the candidate is absent for any reason for the interview, then he/she will not be considered for admission. Any claims regarding this will not be considered later.
3. No TA/DA will be given to applicants to appear for interviews. Proxy is not allowed.
4. Candidates from Dr Babasaheb Ambedkar Marathwada University, Chhatrapati Sambhajanagar will be given preference as per Merit.
5. If no candidate is available from Dr Babasaheb Ambedkar Marathwada University, Chhatrapati Sambhajanagar then second preference will be given to Candidates passing out from other universities within the state of Maharashtra as per Merit.
6. If No candidates are available for the All-India Quota seat, then allotment will be done as per Merit.
7. If candidates are not available from the In-Service Quota seat, then allotment will be done as per Merit.
8. Inter-se amongst the reserved categories will be operated at the end of each admission process against the unfilled reserved categories seats as per merit and choice of the reserved category candidates. The seats remaining vacant from various categories will be filled in the during inter-se admission process as follows:
  - a. From among the candidates of their respective group from the Inter-se Merit List of that particular group where the vacancies exist.
  - b. If the seats still remain vacant, then the seats will be filled, from among the candidates of all the categories mentioned above from all categories combined merit list.
  - c. If the seats remain vacant then the seats will be filled from among the candidates of the common merit list.
  - d. The seats remaining vacant from EWS category will be allotted to general category candidates.
